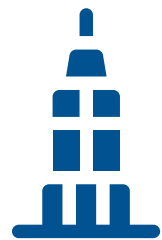

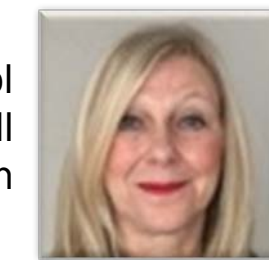

Audit and Compliance Options Matrix



CATEGORY	OVERVIEW	PROCESS
HOTEL	Rate Audit	Verify that PTC's Clients negotiated rates for 2024 are available for each of the remaining months of 2024. Same process for 2025 hotel program
	Compliance Audit	Identify future travel where PTC's Clients employee did not book within travel policy; i.e. PTC's Clients employee did not book a preferred hotel that was available. Emails can be sent directly to the traveler with a copy to the employee's manager if the savings is above a specified amount.
	PNR (Passenger Name Record) Audit	Identify PNR's where PTC's Clients employee booked the preferred hotel but at a higher rate (verifying that preferred rate was available)
	"Squatter Audit"	Identify and notify hotels that were not accepted in PTC's Clients preferred program to remove their listing in the TMC and OBT systems
AIRLINE	Review airline contract metrics and performance	Identify areas of improvement in existing agreements or in advance of expiration
	⁶ Lowest Airfare booked	Review PNRs for lowest fare booked. Emails can be sent to employee if over a set \$ amount or higher class of service than authorized. Separate audit of NDC fares (on airline website) not booked but available
OBT (Online Booking Tool)	Priority Placement Audit for Hotels	Review that PTC's Clients negotiated rates are prominently displayed ahead of TMC rates where lower or at parity
	Top City Audit	Review that PTC's Clients preferred airlines and hotels are prioritized in the display and identified as "Company Preferred"
TMC (Travel Management Company)	Comprehensive Audit	PTC will make suggestions for improving the TMC contract and service level agreement. Comprehensive audit of TMC fees, services, and data quality

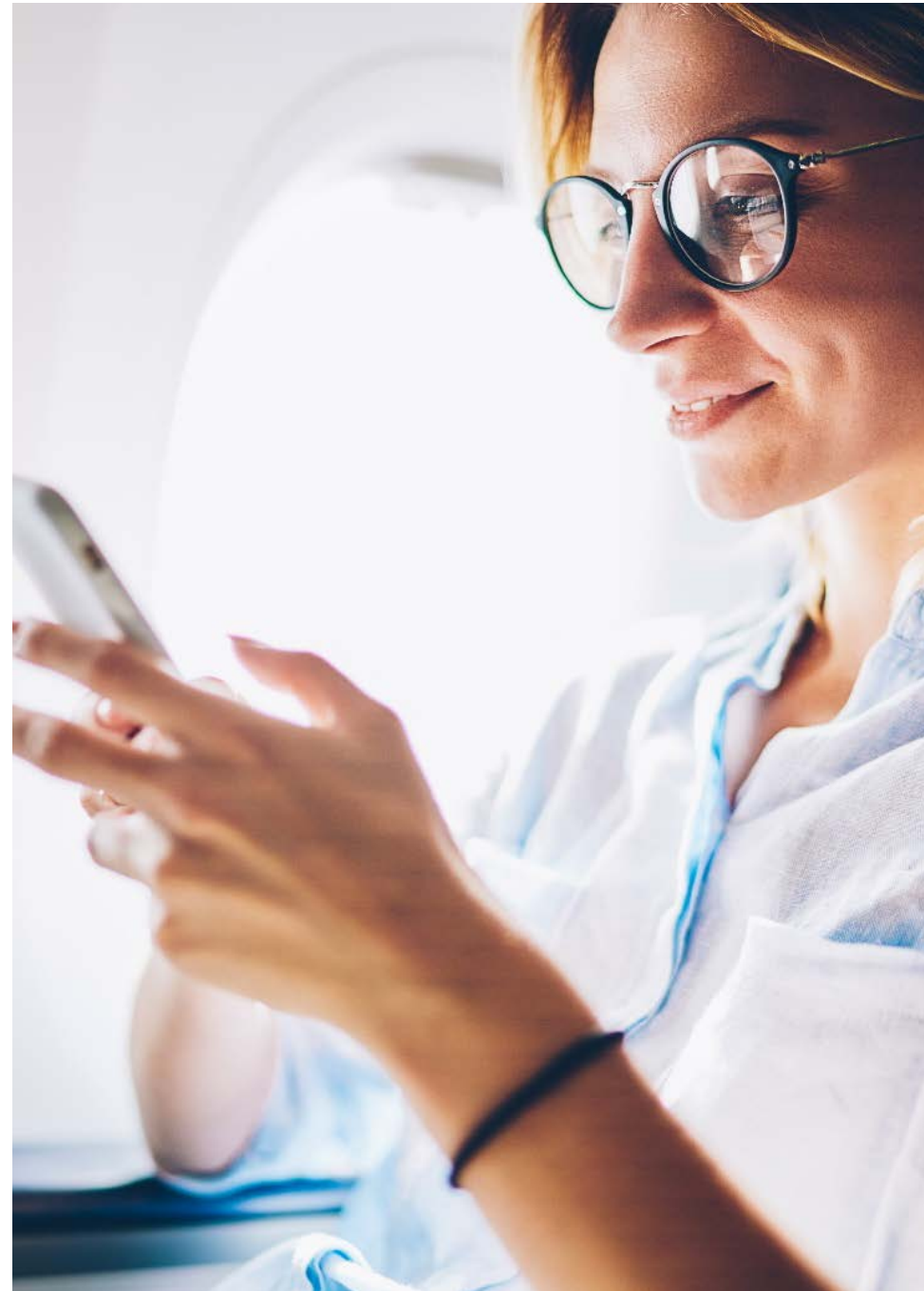

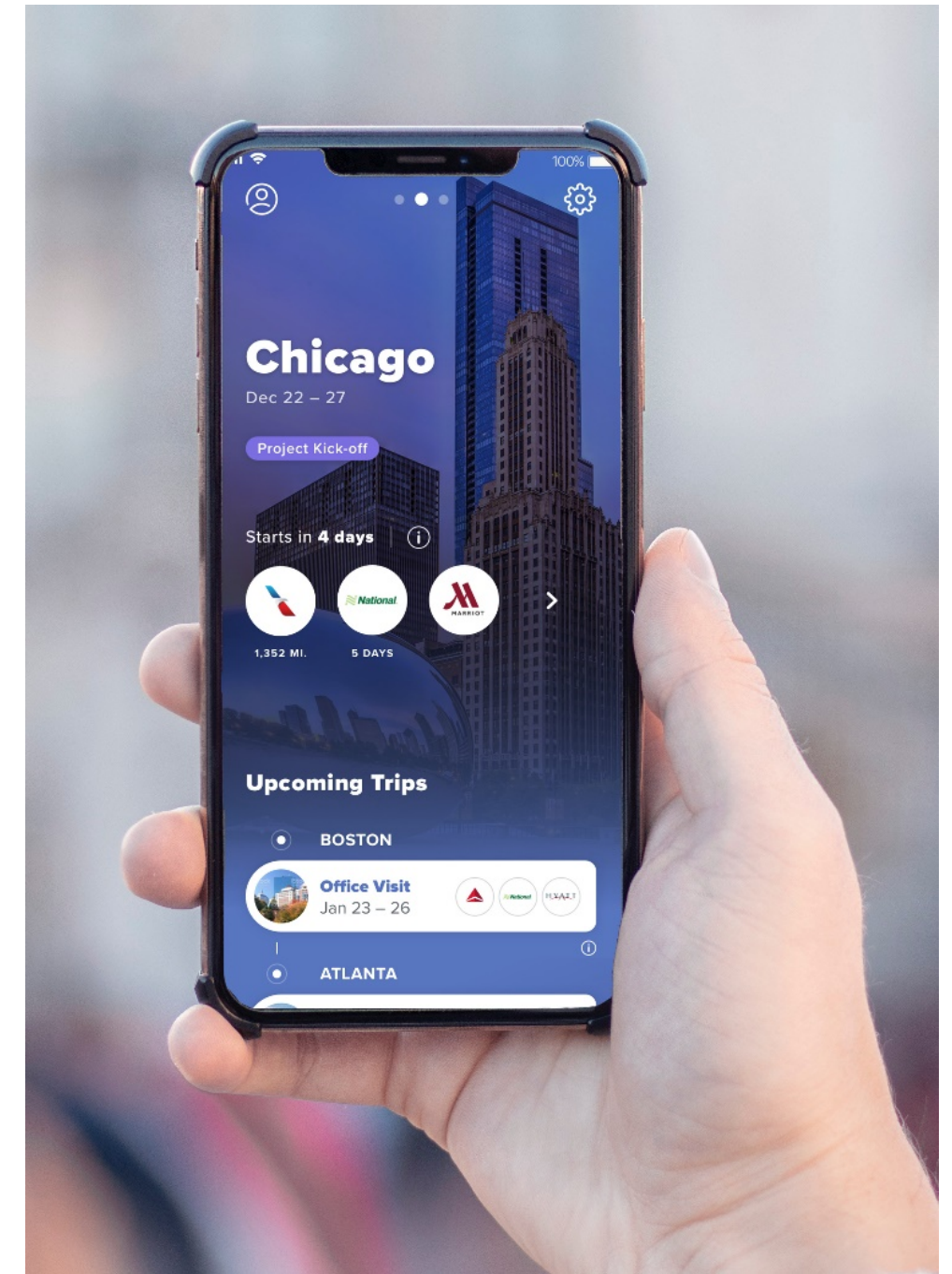

Travel Industry Acronyms

ACRONYM	DECRYPTION	DESCRIPTION
ARC	Airlines Reporting Corporation	Airline-owned entity that licenses all Travel Agencies and CTDs in the US, PR and VI
CTD	Corporate Travel Department	A corporation authorized (by ARC) to issue their own tickets. A CTD is a “Purchaser of Travel”; a Travel Agency is a “Seller of Travel”
GDS	Global Distribution System	The legacy technology platform (dating back 40 years) that Travel Agencies use to book flights, hotels, car rental, rail
NDC	New Distribution Capability	An improved architecture (vs. Edifact for GDS) to more robustly display airline “bundles” and fare attributes
OBT	Online Booking Tool	A user-friendly interface to the GDS to allow travelers and travel arrangers to self-book and then have it flow to the GDS and ultimately the TMC for ticketing. Examples are Concur, Deem, GetThere, Zeno, Neo, Cytric, Atriis
OTA	Online Travel Agency	Web-based consumer-focused travel agency like Orbitz, Expedia and Priceline
PNR	Passenger Name Record	The booking made in the GDS that contains passenger name, contact information, payment and segments (flight, hotel, car rental)
PTC	Partnership Travel Consulting, LLC	www.partnershiptc.com
TMC	Travel Management Company	Travel Agencies that focus on Corporate Travel and charge a fee for their services. Typically a larger travel agency that handles millions of dollars in travel spend for their clients
